NHSA ANNUAL MEETING

2020 NHSA Virtual Annual Meeting

November 10, 2020 at 7 p.m.

Each county will host a meeting place for their clubs, from which all counties will come together to meet virtually. See list below, [contact your county director](#) if you need further information.

The NH Department of Justice, Charitable Trusts Unit does not object to the NHSA virtual annual meeting, as members are allowed to participate and vote.

Delegate Eligibility

Because the annual meeting is taking place in a new fiscal year, the NHSA sought advice from legal counsel in regards to delegate eligibility and delegate count.

Counsel responded with the following guidance, based on our bylaws and rules of business:

In order to be in good standing and to be eligible to participate in the annual meeting which will take place after July 1, both clubs and individual members must have renewed their memberships for the fiscal year 2020-2021 before the annual meeting.

The number and status of delegates is based on the year prior to March 1, and therefore delegate count would be based on the prior fiscal year as outlined in the Bylaws and defined in the Rules of Business.

Delegate Count

Club delegate count information will be sent to the clubs in the upcoming weeks. For planning purposes, Article VI-C-3-b of the bylaws outlines the process for delegate count, as follows:

Each member club is allowed two (2) delegates who must be eighteen (18) years and older as of March 1st of this year. If a member club exceeds 400 club members, said club is allowed one (1) additional delegate for each additional 400 members, with a maximum cap of ten (10) delegates per club.

For example:

2 - 400 members = 2 delegates

401 -800 members = 3 delegates

801 -1200 members = 4 delegates
